COURSE DESCRIPTION

This course is an introduction to the study of law, its structure, and legal institutions from a cross cultural and historical perspective. This interdisciplinary course examines the origins of the legal system in Canada and their impact on society. Included is an analysis of the diverse social, historical, political, economic, moral, and cultural conditions under which the law arises and functions within society. The objectives of this course are four-fold:

- > To familiarize students with the foundation and sources of law
- > To develop a basic understanding of the structure and function of legal institutions
- > To explore the processes of law-making and overview the various legal actors
- ➤ To encourage students to think critically about the role of law and its impacts on different segments of society in conjunction with the application of traditional and contemporary theoretical perspectives

Through a combination of lectures, class discussion and assignments, the goal of the course is to consider the ways in which the law modifies and is modified to uphold particular societal

interests. In addition, students will be encouraged to critically assess the manner in which the law is constituted as a legitimate method to invoke social change.
